1.NAME OF THE TRUST :-

2.REGISTERED OFFICE :-

The registered office of the Trust is situated at H.No.865 Sector-4 Gurgaon, Haryana.

3.AIMS AND OBJECTIVES :-

The aims and objectives of the Trust are as under :-

(i) To provide, establish, maintain, control and manage schools and educational institutions and to do all such acts, deeds and things, as may be conducive for the growth and progress of the institutions.

- (vii) To build, construct, maintain and acquire by purchase, exchange, lease or hire or otherwise, any land, building, right of common playground, park or any moveable or immovable property for the furtherance of all or any of the objective of the Trust.
- (viii) To give loans, scholarships, prizes and monetary assistance to the deserving students and others and to provide funds for the study tours of the members.

4.TRUSTEES: The First Trustees shall be:-

- (i) Satpal Dahiya s/o Sh. Raghunath Dahiya aged 53 years, Resident of H.No. 865 Sector-4, Gurgaon, Haryana
- (ii) Nirmala Dahiya w/o Satpal Dahiya (Vice Chairman), Resident of H.No. 865 Sector-4 Gurgaon, District Gurgaon, Haryana
- (iii) Yogesh Dahiya s/o Satpal Dahiya aged 29 years, Resident of H.No. 865 Sector-4, Gurgaon, Haryana
- (iv) Sumit Dahiya s/o Satpal Dahiya aged 25 years, Resident of H.No 865 Sector-4 Gurgaon, District Gurgaon, Haryana.
- 5. BENEFICIARIES OF THE TRUST: The trust shall be open to all persons irrespective of caste, creed or religion who are eligible for the services provided by the Trust. The funds/ income of the trust shall be used only to achieve the aims and objects of the trust. No funds or income shall be distributed or used for benefit of any trustees or any of their relatives or any concerns in which any trustee is interested.
- 6. BOARD OF TRUSTEES:- The Board of Trustees shall have four members amongst its trustees of the said Trust. Except in so far as may be otherwise provided, all decision of the Board of Trustees shall be taken by a majority vote of the Board of Trustees; in the event of a tie, the Chairman have the casting vote. All questions of interpretation of the scope and ambit of any provisions of this Trust Deed shall be decided by the Board of Trustees, in the first instance by consensus, and failing which by a majority vote. No Trustee holding a minority opinion shall be entitled to raise any dispute regarding the interpretation of the Trust Deed in any form whatsoever. The interpretation of the majority shall also be binding upon the beneficiaries of the Trust.
- 7. CHAIRMAN: The Author/ Settler of the Trust shall be the Chairman of the Trust. He will chair all meetings of the Board of Trustees. In case of his absence at a meeting, the chairman may nominate any other trustee of his choice, to chair the meeting. He may nominate any other Trustee as

Chairman for such period as he may consider right. He shall have right to nominate his successor as well.

- 8. TERM OF TRUSTEES: A trustee once appointed shall remain in office for his/her lifetime, unless terminated as per Clause 10.
- 9. APPOINTMENT OF NEW TRUSTEES: A new Trustee may be appointed by the Board of Trustees on the recommendations from the Managing Board of Trustee by the support of its two third members. Author of the Trust shall have veto Right to refuse trusteeship to any person. Such person appointed as a new trustee must not be below 18 years of age, insane or insolvent.
- 10. TERMINATION OF TRUSTEESHIP: A Trustee may be terminated from office if he/she so desires by resignation or if he/she is unanimously removed by the remaining Trustees, if found guilty of any act deterrent of the objects and purpose of the Trust or in the event the majority of the remaining Trustees feel that such Trustee is unable to carry on his duties as a Trustee or if he is adjudged insolvent or insane. A trustee may resign office as trustee by giving notice in writing to his/her co-trustees.
- 11. DISSOLUTION: The Trust may be dissolved/ revoked by either of the Settlors and upon their death by the Board of Trustees by a resolution adopted by and in presence of all the Trustees. Such resolution shall not be adopted if even one Trustee objects. In the event of dissolution of the Trust, the assets of the Trust, after clearance of all debts and liabilities, shall be transferred to such organisation and/or programme having objects similar to that of the Trust, as the Board of Trustees may decide fit. No part of the properties and assets of the Trust shall be distributed amongst the Trustees.

12. MEETINGS OF THE TRUSTEES: The Trustees or Board of Trustees shall meet from time to time as may be required for the functioning of the Trust. However, an Annual General Meeting must be held once in every 12 months. Such Annual General Meeting must be held in the presence of at

A notice, which must include the agenda to be taken up, must be issued at least 1 month prior to all such meetings. In all issues where voting may be needed by the Board of Trustees, all the Trustees must exercise their vote and in the event, any of them unable to be present, the said Trustee may exercise his/her vote through any other trustee empowered to act on behalf of the said Trustee as the case may be.

- 13. ADMINISTRATION OF THE TRUST: The Trust shall be administered and managed by the Board of Trustees. It may, however, delegates such functions to the managing committee as may be decided by the Board of Trustees from time to time.
- 14. POWER OF TRUSTEES: The Trustees as the Board of Trustees shall have and may exercise all such powers as in their opinion shall enable them to carry out effectively all or any of the Trust purposes. Without prejudice to the generality of the foregoing, the Trustees shall have the power:
- (i) To receive all such grants, donations, presents, gifts etc on behalf of the Trust from any person willing to do so without any binding or prejudice.
- (ii) To receive monies, securities, instruments or other movable and/or immovable property for and on behalf of the Trust.
- (iii) To raise funds for the Trust by gift, donations or otherwise
- (iv) To manage the properties of the Trust and solicit and receive and administer funds, received from any lawful source and to dispose of the same for any purpose of the Trust in any lawful manner.
- (v) To set up a Trust Fund and to open and maintain Bank Accounts etc for the objects and purposes of the Trust.

(vi) To invest in or dispose of such assets or properties as may be required for the objects and purpose of the Trust.

- (vii) To make such expenses as may be required for the initiation, development and construction of such infrastructure as may be required for the objects and purpose of the Trust.
- (viii) To make such expenses as may be required for the maintenance of such projects as may be set up for the objects and purpose of the Trust.
- (ix) To employ clerks and other employees, agents, brokers, bankers, lawyers, accountants and others and at such remuneration as they may think fit for the objects and purposes of the Trust.
- (x) To delegate powers as they can lawfully delegate to any person and to execute such power of attorney as they may think fit for the purpose.
- (xi) To withdraw any power or revoke any appointment of any employee or attorneys,
- (xii) To make all such expenses other than those mentioned above as may be necessary for the objects and purposes of the Trust from time to time.
- (xiii) To borrow money on behalf of the Trust for the objects and purpose of the Trust as may be required from time to time.
- (xiv) To make, sign and execute all such documents and instruments as may be necessary or proper for carrying on the management of the property or office of the Trust.
- (xv) To invest the surplus funds of the Trust which has not been spent in any year in the modes prescribed under relevant laws governing such investments.
- (xvi) To do all such other acts as may be required for the objects and purpose of the Trust.

15. DUTIES OF THE TRUSTIES: All Trustees have such duties as may be deemed for the objects and purpose of the Trust without prejudice to the generality of the foregoing the Trustees shall have the following duties:

To make good for any loss to the Trust property caused due to their fault.

ii. Not to use the property or income of the Trust for their own benefit

iii To maintain accounts of income & expenditure of the Trust

- iv. Not to make any income or earn any remuneration out of the Trust property.
- v. To inform himself of the state of trust property
- vi. To protect title to trust property
- vii. Not to set up title adverse to beneficiary
- viii. To act with care
- ix. To act impartially with respect to beneficiaries
- x. To prevent waste and invest the trust funds and manage them prudently.
- 16. DELEGATION OF POWER: The Board of Trustees delegate such powers and function to the Managing Trustee, Managing Committee or any other person, as may be deemed fit by them from time to time.
- 17. MANAGING COMMITTEE: The Managing Committee shall consists of the Managing Trustee, such other Trustees and such other persons, involved directly in managing the trust activities or its objects or any other special purpose, as may be appointed by the Board of Trustees. All such members will be appointed usually for a period of two years. Any member of the managing committee can be removed by the Board of Trustees by a simple majority at any point of time. The constitution and the meetings of the Managing Committee will be governed by such rules as may be framed by the Board of Trustees from time to time. The managing Committee shall exercise all powers for carrying out the aims and objects of TRUST, which have been delegated by the Board of Trustees for carrying out.
- 18. TRUST FUND: The Trust Fund shall be created and maintained for the expenses of the Trust. The Trust fund shall be deposited by the Trustees In the Bank. This clause will not restrict the right to keep the Trust funds and assets in such security and other assets as the Trustees may from time to time determine. The money or other property received by way of gift and future income thereof shall be held in like trusts in all respects as are herein contained and are applicable to the trust fund and the net income of the trust fund and shall be subject to the same trusts, powers and

provisions as are contained in these presents and applicable thereto as if such money or property had formed part of the original trust funds.

'The trust fund' means and includes-

- a. The sum of Rupees Eleven thousands only as settled by settlers
- b. Any other amounts, stocks, securities and other investments, business, properties and funds which may be substituted or added, the conversion thereof by gift/Donation and/or otherwise, and/or the investments, or conversion of such accumulations, additions and accretion thereto.
- 19. INVESTMENT OF TRUST FUNDS: The Board of Trustees shall invest the money not required immediately for the Trust in accordance with the decision taken in that regard at a meeting of the Board of Trustees and keep accounts thereof. Such funds of the Trust shall be invested and deposited in accordance with the laws governing investments and deposits.
- 20. BANK ACCOUNT: The Trust may also maintain such Bank Accounts as may be required to be so maintained. Such Accounts of the Trust shall be maintained with such bank as the Board of Trustees may determine. Such Bank Accounts may be operated by the Managing Trustee or other Trustee as may be empowered by the Board of Trustees.
- 21. TRUSTEES IN PROFESSIONAL ENGAGEMENT IN TRUST

ASSIGNMENTS: There will be no bar for appointment of any of the Trustees to serve the hospital on payment of salary or other compensation as long as the said Trustee is a professional.

22. REIMBURSEMENT: The Trustees shall be entitled to receive and be paid out of the Trust Fund, all expenses made out of pocket including travelling and other expenses reasonably and legitimately incurred by them in connection with Trust matters and incurred for attending any meeting of the Shaere.

- 23. ACCOMODATION: The Trust, if required, may provide accommodation to all persons engaged in the aims and objects of the Trust. It may also provide for a Guest House for the said purpose and separate accommodation for the Trustees at a place of implementation of the Trust's project or otherwise.
- 24. RULES AND REGULATIONS: For the purpose of the Trust, The Rules and Regulations as may be necessary and as the Board of Trustees may think fit for the management and administration of the Trust, and also from time to time to set aside and vary any such rules and regulations provided, however, that no such rules and regulations shall in any manner be inconsistent with any of the provisions of this Trust Deed.
- 25. AMENDMENTS: Any of the term of this Deed including the Trust purposes set out in clause-5 hereof may be varied, extended or amended from time to time by an instrument in writing under the hands of the Trustees, to be approved by them at a meeting convened for the specific purpose, provided no variation, extension of amendment shall be valid if it is contrary to or inconsistent with the Trust purpose set out in Clause-5 hereof.
- 26. IMPOSSIBILITY TO PERFORM OBJECTS: In case of failure of the Trust of the Trust for the want of its objects or Trust having become impossible of performance, the Trustees will apply to Court for directions to pursue similar objects as may be deemed by the Court.
- 27. ARBITRATION: In case of any dispute between any parties to the Trust, such parties shall try to arrive at a compromise, failing which they will refer the dispute to an Arbitrator shall be final and binding.

28. LEGAL REPRESENTATION: The Trust will be represented, in the event of any legal dispute, by the Managing Trustee or such other person, as the Board of Trustees may decide to choose.

ACCOUNTS AND AUDITS: All accounts are to be maintained by the Managing Trustees and such accounts shall contain proper particulars of the money received and expended by the Board of Trustees and the matters in respect of which such receipts and expenditure take place as also such other particulars as may be usual in account of a like nature, The books of accounts and other papers and documents relating to the said Trust shall be kept at the office of the Trust and shall be open to inspection by the Board of Trustees at all reasonable time. Such account is to be audited by a Chartered Accountant, appointed by Board of Trustees, for the Accounting year of 1st April to 31st March of each year. Such audited account shall be presented before the Board of Trustees by the Managing Trustee at the Annual General Meeting of the Board of Trustees immediately following.
